PRECAUTIONARY STATEMENTS

Avoid breathing spray mist. Harmful if swallowed, inhaled or absorbed through skin. May cause irritation. Avoid contact with eyes.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If on skin: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

GENERAL INFORMATION

Wick™ is designed to enhance the spreading and penetration of insecticidal treatments on textile substrates such as carpets, rugs and mattress ticking. Wick can also be used to aid indoor crack and crevice treatments. Wick may also be used in commercial kitchens but must be kept away from areas where foot traffic occurs.

Do not use Wick on any vertical surfaces where gravitational streaking may damage the appearance or integrity of the material.

DIRECTIONS FOR USE: READ ENTIRE LABEL BEFORE USING. Wick is an indoor/outdoor adjuvant designed to improve the physical distribution and absorption properties of pesticides into fibers and onto labeled surfaces. Extreme caution must be taken to keep spray solutions containing Wick away from traffic or walking areas on non-textile, smooth or slippery surfaces.

USE RATE

Add Wick at the rate of 0.5% v/v or 18 milliliters (2/3 ounce) per gallon of finished spray solution.

MIXING INSTRUCTIONS

Impermeable gloves should be worn when handling chemicals. Add Wick during filling process of the spray unit while agitation is ceased to minimize foaming. Once the spray solution has been completed, secure the lid and agitate the solution. Small hand unit sprayers may be shaken or swirled for agitation.

SPECIAL CAUTIONS

Wick is a non-ionic adjuvant to be used with insecticides or other pesticides labeled for indoor/outdoor use. Because of its ability to wet, spread and penetrate the spray solution, Wick is not labeled and **cannot be used** on areas where improved wetting and/or penetration could cause damage or promote unsafe or unstable surfaces. This could include but is not limited to walls and hard floor surfaces.

Wick has the ability to re-wet which could result in slippery conditions on hard or slick flooring surfaces, if water or moisture contacts that area at a later time. This could promote slippery or dangerous conditions on hard flooring surfaces where foot traffic occurs. Always follow label directions; do not allow re-entry to treated surfaces by people or pets until the spray has had sufficient time to dry.

STORAGE AND DISPOSAL

Storage: Keep product in original container. Do not contaminate water, food or feed by storage or disposal.

Container Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. Contact your state and local ACRC recycler or visit the ACRC web page at www.acrecycle.org. Decontaminated containers may also be disposed of in a sanitary landfill.
