### HOW TO USE

<b>PERIMETER TREATMENT</b>	
<b>PESTS</b>	Ants, Centipedes, Cockroaches, Crickets, Digger Wasps, Earwigs, Millipedes, Pillbugs, Scorpions, Sowbugs, Spiders
<b>HOW MUCH TO APPLY</b>	1/3 to 1/2 cup per 45 to 50 ft. (2 to 3 ft. band) 2 to 3 lbs. per 1000 sq. ft. Covers 5,000 sq. ft. (a band 10 feet wide and 500 feet long.) 1 to 2 tsp. per mound or wasp burrow
<b>HOW TO APPLY</b>	<b>Around the House</b> To keep these pests away from your home, apply granules in a band 2 to 3 feet wide around and up to the building. <b>TIP:</b> A hand-held spreader makes this easy. <b>For Ant Mounds or Wasp Burrows</b> Sprinkle 1 to 2 teaspoons of granules over the ant mound or wasp burrow. Treat wasps at night, after they are back in their nest.
<b>TO CONTROL PESTS IN AND AROUND THE LAWN</b>	
<b>PESTS</b>	Annual Bluegrass Weevil (hyperodes), Ants, Hyperodes Weevil (adults), Armyworms, Billbugs (adults), Black Turfgrass Ataenius (adults), Chiggers, Chinch Bugs, Cutworms, Fleas, Grasshoppers, Leafhoppers, Mealybugs, Mole Crickets, Sod Webworms (Lawn Moths), Ticks (including deer ticks)
<b>HOW MUCH TO APPLY</b>	Apply 2 to 3 lbs. per 1000 sq. ft. (This bag covers up to 5000 sq. ft.) Adjust your spreader to the proper setting. See table.
<b>HOW TO APPLY</b>	Use rotary or drop type spreaders to apply granules evenly over the lawn. To be sure you cover the entire area uniformly, first treat the border of the lawn then fill in the center. Make parallel passes, walking at a steady pace to ensure even distribution of the granules. Water thoroughly within a day after applying. <b>TIP:</b> For best control of mole crickets, apply during the period when their eggs are hatching. Contact your County Extension Agent for the ideal dates to apply in your area.

<b>HOW MUCH TO APPLY</b>	1/4 cup per mound
<b>HOW TO APPLY</b>	Fire Ant mounds. Sprinkle evenly over mound. Treat new mounds as they appear.
<b>FOR BEST RESULTS</b>	Water in thoroughly after applying. Do not mow until the granules are thoroughly watered in. To prevent damage, apply this product early—when pests are still young and easier to kill.
